ITEM ELPP008/24 - DRAFT WESTMEAD SOUTH MASTER PLAN AND PLANNING PROPOSAL

BACKGROUND

The Panel was provided with an assessment report and supporting documents including the draft planning proposal, master plan, DCP and affordable housing strategy and a range of supporting technical studies.

The Panel was briefed by Council staff, heard from members of the public who wished to address the Panel, and also considered further written submissions. The key matters raised by members of the public were:

- Heritage, including rationale, scope of heritage items and heritage conservation areas, and opportunities to reflect the unique character of the area.
- Maintaining the unique sense of community for existing and future residents.
- Potential impacts of population growth, including traffic and amenity concerns.
- Role of Westmead in the context of Greater Sydney.
- Provision of affordable housing.
- Proximity to key infrastructure including hospitals, schools, universities and public transport, including the Metro to warrant further development.

The Panel recognises the planning proposal is evidence based, and has strategic merit, and recommends that Council officers address these matters further in their final report to Council.

That the Cumberland Local Planning Panel recommend to Council that the Westmead South Planning Proposal and associated documents be endorsed and forwarded to the Department of Planning, Housing and Infrastructure for a Gateway Determination.
